**DATES:** Sat, Nov 22<sup>nd</sup> and Sun, Nov, 23<sup>rd</sup>, 2025

**LOCATION:** Laushe Building - Ohio Expo Center, 717 E. 17th Ave, Columbus, OH 43211

**SET-UP:** Friday, Nov. 21<sup>st</sup>, 2025 — 3PM to 7PM and Saturday Nov 22<sup>nd</sup>, 2025—6AM to 9AM

**ELIGIBILITY:** Artists/crafts persons should exhibit and sell handcrafted work of only the highest caliber. We reserve the right to remove from the show any work which does not reflect the same quality as that presented for jury review. Individuals may request to exhibit together, but everyone's items must be juried separately.

**ENTRY:** Applicants must submit 4 images of items representative of the quality of the work to be exhibited and sold. Images must be submitted by email. Images should be 1920 pixels on the longest side (height or width) and must be 300 dpi. One of the images must be of your booth setup. Applicants are rated by a jury on the quality of their work and selected by promoters based on their jury ratings and the availability of openings in each category. Any jury materials submitted will be used for advertising purposes unless artist/crafter indicates otherwise. Valid vendors license required.

**FEES:** See application for fee schedule. Applications must be accompanied by a \$100 deposit check and a separate \$15 or \$20 jury fee check, both made payable to VINTAGE PROMOTIONS; the balance is due October 15, 2024. Deposit checks are not deposited until an artist/crafter is accepted into the show. Applications will be accepted until the show is full.
